WHEREAS: The bill would be recalculated annually to ensure that wages would be no less than 135 percent of the federal poverty line for a family of four; and

WHEREAS: This bill is supported by unions, Massachusetts Council of Human Service Providers, SEIU Local 285 and Local 925 and the Massachusetts chapter of the Alliance for the Mentally III; now therefore be it

RESOLVED: That this City Council go on record in support of the Living Wage for Human Service Workers pending legislation; and be it further

RESOLVED: That the City Clerk be and hereby is requested to forward a suitably engrossed copy of this resolution to the entire Cambridge legislative delegation in both the House and Senate on behalf of the entire City Council.
