## MAYOR MAHER

- WHEREAS: Governor Deval Patrick filed legislation on Jan 22, 2010, entitled "An Act Relative to Municipal Relief"; and
- WHEREAS: The City of Cambridge should have access to a diverse array of financial tools for coping with the current economic climate; and

- WHEREAS: Section 25 of HB4526: An Act Relative to Municipal Relief provides an optional Early Retirement Incentive Program for cities and towns; and
- WHEREAS: This program would allow a limited number of long term employees to receive early retirement benefits, while restricting the City's ability to refill those same positions to no more than 30%, 45% and 60% of the former total salaries over the next three years, respectively; and
- WHEREAS: The Early Retirement Incentive Program would provide the City of Cambridge the authority to determine whether this program is appropriate for our community; now therefore be it
- RESOLVED: That the City Council go on record urging Cambridge's Delegation to the Great and General Court to support Section 25, the Municipal Early Retirement Incentive Program, contained in the HB4526: An Active Relative to Municipal Relief; and be it further
- RESOLVED: That the City Clerk be and hereby is requested to transmit copies of this resolution to The Senate President, The Speaker of the House and the entire Cambridge Delegation to the Great and General Court.

- COUNCILLOR CHEUNG
- WHEREAS: Despite the fact that chronic viral hepatitis is the most common blood borne infection in the United States, there is currently no routine and universal screening in place for early detection; and
- WHEREAS: Hepatitis B is a serious infection of the liver caused by the hepatitis B virus (HBV), and can lead to premature death from liver failure or liver cancer, with an estimated 46,000 new infections domestically each year; and
- WHEREAS: HBV is dubbed a "silent killer" because it often infects people without symptoms, and when symptoms do appear, it is often too late for treatment to be effective; and
- WHEREAS: A simple 3-shot hepatitis B vaccine can provide lifelong protection against HBV; and
- WHEREAS: Although Asians represent less than 10% of the total population in the Boston area, they account for greater than 50% of new chronic hepatitis B cases; and
- WHEREAS: The goal of Hepatitis B Awareness Week is to highlight the global nature of chronic viral hepatitis epidemics and recognize the need for a comprehensive public education and awareness campaign designed to help infected patients and their physicians identify and manage the secondary prevention of the disease, and to help increase the length and quality of life for those diagnosed with chronic hepatitis B infection; now therefore it be
- RESOLVED: That the Cambridge City Council declares the week of May 16-22 "Hepatitis B Awareness Week;" and be it further
- RESOLVED: That the Cambridge City Council supports raising awareness of the risks and consequences of chronic hepatitis B infection, and the urgency for a robust governmental and public health response to protect the health of Cambridge residents; and be it further
- RESOLVED: That the City Clerk be and hereby is requested to forward a suitably engrossed copy of the resolution to TEAM HBV at Harvard on behalf of the entire City Council.

## COUNCILLOR CHEUNG

- WHEREAS: Not since 2003, when the City commissioned a report from HMFH Architects, Inc., has the city looked into the feasibility of a wind turbine at Danehy Park and the wind harvesting potential of said site; and
- WHEREAS: Since the release of this report the price of electricity has skyrocketed; and
- WHEREAS: The 2003 report only allowed for the consideration of a 250 kW turbine; and
- WHEREAS: New technology can accommodate a 600 kW turbine or larger; and
- WHEREAS: Since the release of the HMFH Report, the cities of Medford and Hull have instituted successful wind turbine programs that have far exceeded expectations, with Hull's second wind turbine being siting on a former landfill, similar to Danehy Park; and
- WHEREAS: A wind turbine in Cambridge could not only be a proud and visible stepping stone to a greener future but could also save the city millions of dollars in electricity over time; now therefore it be
- ORDERED: That the City Manager be and hereby is requested to confer with the appropriate department heads on requisitioning a study on the feasibility of a wind turbine at Danehy Park and the wind harvesting potential of the site; and be it further
- ORDERED: That the report include measurements for the largest possible turbine for the site and analyze the advantages of Danehy Park, including its higher elevation than the surrounding area.

COUNCILLOR CHEUNG

- WHEREAS: The Cambridge City Council is always looking for new ways to green our economy and stimulate job growth; and
- WHEREAS: Property Assessed Clean Energy (PACE) enabling legislation would allow Cambridge to establish voluntary opt-in improvement districts, known as PACE districts, to help property owners finance investments for energy efficiency and renewable energy investment; and
- WHEREAS: This arrangement spreads the cost of clean energy improvements-such as energy efficient boilers, upgraded insulation, solar installations, etc - across a payment plan that automatically transfers to the next property owner if the property is sold; and
- WHEREAS: Surveys report that limited capital availability is cited as the most common barrier to capturing potential energy savings, and PACE bonding mechanisms offer many advantages over traditional loans for financing energy efficiency retrofits; and
- WHEREAS: The PACE bond market has the potential to dramatically accelerate the energy retrofitting of America's building stock and the passage of PACE legislation would benefit property owners, existing lenders, and create job growth; and
- WHEREAS: PACE enabling legislation has passed in nearly twenty states over the past year; and
- WHEREAS: PACE enabling legislation is now up for debate in the Massachusetts State House, Bill #4393; now therefore be it

- ORDERED: That The Cambridge City Council go on record urging the Cambridge delegation to support said legislation; and be in further
- ORDERED: That the City Clerk be and hereby is requested to transmit copies of this order to the entire Cambridge Legislative Delegation on behalf of the entire City Council.
