#### TEXT OF ORDERS

O-1 May 21, 2012

### **COUNCILLOR TOOMEY**

- WHEREAS: The Northpoint Park operated by the Department of Conservation and Recreation has quickly become a jewel in the Charles River park system and a much welcomed addition to the Cambridge neighborhood; and
- WHEREAS: A number of improvements to the Lower Charles River Basin, including Northpoint Park, are legal obligations and mitigation for the negative impacts of the Big Dig; and
- WHEREAS: The complete vision for the area includes a bridge and park system that allows pedestrians and bicyclists unimpeded access to the Lower Charles Basin and creates new connections that will benefit the Cambridge and Boston communities; and
- WHEREAS: With the newly constructed North Bank Bridge, another of these obligations, the State has created a new connection spanning the railroad tracks and linking the Charlestown and Cambridge communities; and
- WHEREAS: The Inlet Bridge, is a bridge that would improve access to the park and Lower Charles River Basin from the Cambridge side of the river; and
- WHEREAS: The Inlet Bridge is a pedestrian connection that would span the Charles River and connect Northpoint Park to Monsignor O'Brien near the Museum of Science; and
- WHEREAS: It has come to the attention of the City Council that the legal obligation to construct the Inlet Bridge is being disputed by state agencies; and
- WHEREAS: Mitigation promised to the citizens of Cambridge by the Commonwealth should be upheld; now therefore be it
- ORDERED: That the City Manager be and hereby is requested to confer with the Law Department and report back to the City Council on the current status of the Inlet Bridge and steps the City can take to ensure that agreements with the Commonwealth are upheld.

- WHEREAS: Generally, Cambridge Open Space Zoning Regulations require that a specified minimum portion of a lot remain open and usable to the public and provide active street level use by the public; and
- WHEREAS: Cambridge Citywide Urban Design Objective (Zoning Code: 19.32) states that "New development should be pedestrian and bicycle-friendly, with positive relationship to its surroundings"; and
- WHEREAS: Cambridge Citywide Urban Design Objective (Zoning Code: 19.37) states that "Enhancement and expansion of open space amenities in the city should be incorporated into new development in the city ... on large-parcel commercial developments, publicly beneficial open space is provided"; and
- WHEREAS: The Novartis campus building (formerly the NECCO Factory site) located on 254 Massachusetts Avenue has open space in the form of plazas, landscaped areas and pedestrian pathways integrated into the site so as to benefit building users and the general public; now therefore be it
- ORDERED: That the City Manager be and hereby is requested to direct the Community Development Department to work together with Novartis to ensure public pedestrian connections are encouraged through the site and that any measures, such as installed fences or gates, remain open during daylight hours seven days a week for public access; and be it further
- ORDERED: That the City Manager be and hereby is requested to report back to the City Council on this topic.

### COUNCILLOR VANBEUZEKOM

- WHEREAS: The Traffic, Parking and Transportation
  Department appropriately allows disabled residents to
