- 12. Proposed amendment to the Zoning Ordinance to rezone land in the area on and near Massachusetts Avenue in the Riverside and Mid-Cambridge areas. The question comes on passing to be ordained on or after June 29, 1998. Deadline for action on petition is August 11, 1998.
- 13. Proposed amendment to the Municipal Ordinance regarding a draft amendment to exempt various bell towers from the operation of the Noise Ordinance. The question comes on passing to be ordained on or after July 6, 1998.
- 14. Relative to an order requesting the appropriation and authorization to borrow \$2,770,000 from the Massachusetts Water Pollution Abatement Trust to provide funds to conform with the Department of Environmental Protection Consent Order requiring the City to improve the protection provided for the receiving with regard to sanitary pollution. The question comes on passing to be ordained on or after July 6, 1998.
- 15. Relative to an order requesting the appropriation and authorization to borrow \$1,200,000 from the Massachusetts Water Pollution Abatement Trust to provide funds a program which improve the storm system capacity and improves the cleaning and collection program. The question comes on passing to be ordained on or after July 6, 1998.
- 16. Proposed amendment to the Zoning Ordinance to amend the zoning in the Northern Massachusetts Avenue area. The question comes on passing to be ordained on or after July 6, 1998. Deadline for action on petition is August 11, 1998.

12.16.100 Sidewalks--Obstruction--Fruit peelings.

B. No person shall wilfully and maliciously tip over and spill out the contents of any box or barrel containing ashes or other house dirt set upon the sidewalk. No person shall throw or place upon any sidewalk or crosswalk any banana skin, orange peel or other slippery substance. (Prior code § 17-40)
