- WHEREAS: It has come to the attention of the City Council that the Vail Court property on Bishop Allen Drive is presenting a public safety issue; and

- WHEREAS: This City Council has learned that the custodians who clean most of the office buildings in Cambridge are negotiating their contract as members of SEIU Local 615 with cleaning contractors who operate in Cambridge; and
- WHEREAS: Many of these contractors have been charged by the union with unfair labor practices and have been charged with violating the Section 7 Rights of the National Labor Relations Act which guarantee under Federal law that workers shall be able to bargain collectively with their employers; and
- WHEREAS: The building owners and tenant companies who hire these contracted cleaning companies have the ultimate responsibility for their conduct as the contracting agent; and
- WHEREAS: The City of Cambridge has expressed its goal to encourage companies operating within the City to provide more good paying, full-time jobs with benefits as expressed in such

- documents as the Cambridge Living Wage Ordinance and many other resolutions; and
- WHEREAS: The contractors have expressed a desire to lower wages, remove full-time work and benefits despite the fact that the Cambridge office realty market remains vibrant and has some of the lowest vacancy rates in the country; and
- WHEREAS: Contractors such as ABM and Unico have contacted the Cambridge Police in an attempt to suppress the collective action of unionized janitors in this city; now therefore be it
- RESOLVED: The Cambridge City Council goes on record strongly condemning the attempt of any company operating within its borders to use intimidation to suppress the Federal collective bargaining rights of employees; and be it further
- RESOLVED: The Cambridge City Council calls on cleaning contractors operating in Cambridge to bargain fairly and to uphold the community standards of good jobs and benefits for those who work and live here; and be it further
- RESOLVED: The Cambridge City Council calls on building owners and large corporate tenants to closely monitor the activity of those contractors that they have hired to ensure that they are upholding community standards and are in compliance in both the letter and spirit of all applicable State and Federal laws regarding the rights of workers to collectively bargain over their wages, benefits and working conditions as the City of Cambridge responsible contracting agent; and be it further
- RESOLVED: That the City Manager be and hereby is requested to instruct the Cambridge Police Department to uphold normal safety functions that shall not be utilized to suppress the normal collective bargaining rights and actions of members such as to suppress their freedom of assembly and/or to meet peaceably; and be it further
- RESOLVED: The Cambridge City Council calls upon both the SEIU Local 615 and the negotiating contractors to strive toward a resolution in which the community standards of the City of Cambridge are upheld and the normal operation of business is not disrupted; and be it further
- RESOLVED: That the City Clerk be and hereby is requested to forward a suitably engrossed copy of this resolution to ABM and Unico on behalf of the entire City Council.
