- WHEREAS: The MBTA has responded to this concern by offering weekly passes beginning on January 1, 2001; and

WHEREAS: The success of the weekly pass program will be directly related to the ease of purchase of these passes; now therefor be it

- RESOLVED: That this City Council thank the MBTA and Secretary of Transportation and Construction Kevin Sullivan for introducing free bus transfers and weekly passes; and be it further
- RESOLVED: That this City Council urges the MBTA to make the purchase of weekly passes easier by providing many locations for purchase; and be it further
- RESOLVED: That the City Clerk forward a suitably engrossed copy of this resolution to the MBTA on behalf of the entire City Council.

#### O-15. Oct 23, 2000 MAYOR GALLUCCIO

- WHEREAS: It has come to the attention of this City Council that service on the MBTA Route 72 bus during morning and evening rush hour is frequently behind schedule; and
- WHEREAS: The MBTA has in the past considered reducing service on the Route 72 bus line and it has been rumored that such a reduction in service is being considered for the winter schedule; and

WHEREAS: Residents who live on the 72 bus route are severely limited in other options for bus service; and

WHEREAS: The City has been and continues to encourage the use of public transit to reduce automobile congestion and vehicle emissions; now therefore be it

- ORDERED: That the City Manager contact the MBTA regarding the regular lateness of rush hour service on the Route 72 and request the MBTA to take action to improve service on this route; and be it further
- ORDERED: That the City Manager request that the MBTA provide complete information regarding planned service cuts on the Route 72 and all other Cambridge bus routes for the Winter and Spring schedules; and be it further

- ORDERED: That the City Manager report back to this City Council at the earliest possible time regarding these requests; and be it further
- ORDERED: That a copy of this Order be forwarded to Robert Prince, General Manager of the MBTA reflecting the entire City Council's concern over late service on the Route 72 bus and concern over cuts to this and other bus routes in Cambridge.
