# Planning Board:

- Under Chapter 652 of the Acts of 1960, the City Planning Board was abolished, and the staff was transferred to the Boston Redevelopment Authority (BRA), and the functions, duties, and responsibilities for general city planning were assumed by the Authority.
- Members receive stipends. However, the website and City published materials do not list the amount.

# <u>ZBA</u>:

- 7 members, appointed by the Mayor for a term of three years.
- Members and alternate members receive a stipend of \$200 per day of service, up to a maximum of \$24,000 per year.

#### Historic Board:

- Boston does not have a single Historic Board. Instead, it has a variety of boards focusing on neighborhoods or other historic focuses.

- 10 members, appointed by Mayor and state, appointed for a term of five years.

- Other Boston historic boards also do not receive stipends.
