#### AN INITIATIVE PETITION.

Pursuant to Article XLVIII of the Amendments to the Constitution of the Commonwealth, as amended, the undersigned qualified voters of the Commonwealth, ten in number at least, hereby petition for the enactment into law of the following measure:

# The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

Proposal for a legislative amendment to the Constitution An Initiative Petition for an Amendment to the Constitution of the Commonwealth to Provide Resources for Education and Transportation through an additional tax on incomes in excess of One Million Dollars.

Not less than one-fourth of all the members elected to the Senate and House of Representatives, in joint session, hereby declares it to be expedient to alter the Constitution by the adoption of the following Article of Amendment, to the end that it may become a part of the Constitution [if similarly agreed to in a joint session of the next General Court and approved by the people at the state election next following]:

# ARTICLE OF AMENDMENT.

- 1 Amendment Article XLIV of the Massachusetts Constitution is hereby amended by adding the
- 2 following paragraph at the end thereof:

3 To provide the resources for quality public education and affordable public colleges and

4 universities, and for the repair and maintenance of roads, bridges and public transportation, all

5 revenues received in accordance with this paragraph shall be expended, subject to appropriation,

- 6 only for these purposes. In addition to the taxes on income otherwise authorized under this
- 7 Article, there shall be an additional tax of 4 percent on that portion of annual taxable income in

8 excess of \$1,000,000 (one million dollars) reported on any return related to those taxes. To

9 ensure that this additional tax continues to apply only to the commonwealth's highest income

- 10 residents, this \$1,000,000 (one million dollar) income level shall be adjusted annually to reflect
- 11 any increases in the cost of living by the same method used for federal income tax brackets. This
- 12 paragraph shall apply to all tax years beginning on or after January 1, 2019.

## Summary of 15-17.

This proposed constitutional amendment would establish an additional 4% state income tax on that portion of annual taxable income in excess of \$1 million. This income level would be adjusted annually to reflect increases in the cost of living by the same method used for federal income-tax brackets. Revenues from this tax would be used, subject to appropriation by the state Legislature, only for public education, public colleges and universities, the repair and maintenance of roads, bridges, and public transportation. The proposed amendment would apply to tax years beginning on or after January 1, 2019.
